Track; Jess Feist – Volunteer Football, Jesse Glines – Volunteer Football, Ray Ginsbach – Volunteer Football, Marisa Hett- Volunteer Volleyball, Brad Johnson – Volunteer Wrestling, Brady Harkless – Volunteer Wrestling, Taz Olson – Volunteer Wrestling. Motion carried.

**19-190** 1<sup>st</sup> Reading Handbooks. First reading was held of the Elementary and Middle School/High School Handbooks. Current changes to the handbooks include: an updated bell schedule and calendar, adding information about the chain of command, and policy updates that occurred during the last school year.

**19-191 Canvass Election**. Business Manager Henderson canvassed the election with the board. The election was held on June 4, 2019. There were four candidates up for two 3-year terms. The final vote tally was: Laura Johnson - 187, Randy Routier - 171, Tracy Teigen - 128, and Travis Smith - 54. Laura Johnson and Randy Routier were re-elected to their positions.

**19-192 Board Appointment Date**. There will be a special meeting held on June 24, 2019 at 5:30pm to interview and appoint a board member to a one-year term. Three letters of interest were received for this board position.

## Open Forum

Matt Rolph asked if the board would consider changing the start time of the board meetings to a later time.

**19-193 Change of Attendance Center.** Motion by Gilbert, second by Routier to approve a change of attendance center from Camp Crook to Buffalo for Brylen and Kanyn Padden. Motion carried.

19-194 Negotiated Agreement. The Negotiated Agreement was tabled until the July board meeting.

**19- 195 NWAS**. Routier gave the NWAS report. The mobile units will be moved this month. The base assessment for the mobile units went up \$750 to \$85,500 for next school year and is expected to increase again the next year. The assessment for Special Education also when went up.

**19-196 Business Manager**. Dougherty and Co. was able to re-sell all of the capital outlay bonds for the refinance. All in all, the district will save just over \$176,000 in interest costs. The previous interest rate was approximately 5.5% and the new interest rate will be 2.49%. The bond refinance will close on June 19, 2019. Motion by Routier, second by Gilbert to transfer funds from the Pension Fund to the General Fund for the 2018-2019 retirement costs, not to exceed \$80,372.00 as budgeted. Motion carried.

**19-197 Principal/AD.** Principal Messmer (via phone) discussed the principal's report. Congratulations to Camden Hett for placing 3<sup>rd</sup> in the State Triple Jump. Congrats also to Jesse McCann and Zack Anders for

qualifying and competing in the State Golf Tournament in Yankton. Every sports team has been recognized as Academic All-State. Good luck also to the National History Day students as they are in Washington, DC currently competing.

**19-198 Superintendent**. Supt. Page is currently working on the Consolidated Application and will have the budget completed for the budget hearing in July. So far summer cleaning is ahead of schedule. A compressor needs to be replaced in the high school wing for the air conditioning unit.

Superintendent Page also wished to express deepest condolences on behalf of the Board, Administration, Staff, and Students to the Klempel and Lermeny families on the sudden passing of Jaxon Klempel. He was one of a kind and will be missed.

**19-199 Executive Session**. Motion by Routier, second by Gilbert to enter into executive session pursuant to SDCL 1-25-2(4) for contract negotiations at 5:59pm. Motion carried. The board was declared out of executive session at 6:15pm. Member Johnson left the meeting at 6:10pm.

President Glines declared the meeting adjourned at 6:15pm.
