<p>IV. Class four infraction Includes: Possession or use of alcohol or drugs on campus or at school functions. Smell, behavior, and physical possession of drugs or alcohol will determine reasonable suspicion. Schools do not need drug tests or breathalyzer tests to suspend. Evidence relating to reasonable suspicion of probable use or possession must be reported immediately and investigated in a timely manner. (2) Suspension from school 3 to 10 days for distribution of drugs or alcohol.
