23-143 SDHSAA Membership. Motion by Clanton, second by Gilbert and carried to approve Resolution 2023-3 Authorizing Membership in the South Dakota High School Activities Association.

By resolution of the School Board of Harding County has authorized membership in the SDHSAA for the high school under its jurisdiction as hereinafter listed: Harding County High School. This is to be for the period which begins July 1, 2023, and ends on June 30, 2024, with supervision, control, and regulation of any and all high school interscholastic activities being delegated to said Association. In addition, the above-mentioned School Board has ratified the Constitution, By-Laws, and rules of the SDHSAA as of July 1, 2023, and agrees to conduct its activities programs within the framework of these instruments.
